• Joanne Jamison (JJ) distributed papers showing the up-to-date position in respect of resource funding based upon the January monitoring budget profile, opening budget 2014-15, planning for the 2015-16 budget, prompt payments, Account NI KPIs and FSD KPIs. The outturn showed an easement of £28K against staff costs and £65K against non-staff costs. Discussions were raised around the variances between the actual and budgeted expenditure and all points raised were dealt with by JJ.

- DW suggested that a process be agreed with Sponsor Department in respect of the
 yearly submission of the pay remit business cases as CJI encounter the same
 protracted delay every year to approve staff salary increases. JC advised that CJI
 cannot proceed with the preparation of pay remits until the NICS agree their pay
 increases but the principle remains that all staff are contractually entitled to an uplift
 in salary. Based on previous experience, JC and MMcV met with Sponsor
 Department in February to try to expedite the process this year.
- JC agreed to speak with other NDPBs to solicit their views and experience in relation to staff pay remits.
