

Our understanding of the information requested in relation to the 2008-09 financial years as follows:

- a list of all events hosted by this organisation costing £1,000 or more plus the date, location, details and costs of the events;
- a list of staff team building or 'thinktank' events during the same period plus the location and total cost of the same
- a list of all overseas visits made by people from the organisation or arranged and paid for by this organisation with details including date, location, number of people who travelled, mode of travel, hotel details and total cost

- a list of all promotional material produced by the organisation and the cost of production and distribution of same and if applicable,
- a breakdown of costs involved in any re-branding undertaken by the organisation.
